Normal production operations were observed.

During the inspection, the following compliance issues were observed:

- 1) Storage of unused supplies/equipment on location
- 2) Multiple open-ended lines at pits on location
- 3) Unmarked deadmen on location
- 4) Multiple open-ended load lines on storage tanks

A follow-up on this site inspection will be conducted to ensure the compliance issues have been corrected to comply with CECMC rules.
