INITIAL ACTION SUMMARY

Description of initial action or emergency response measures take to abate, investigate, and/or remediate impacts associated with E&P Waste.

Pursuant to ECMC Rule 911 a site investigation was conducted pertaining to the BRUNTZ G16-23 wellhead cut and cap and flowline removal. Approximately 1056' of flowline was removed. The wellhead was cut and capped per ECMC rules. Additionally, soil samples were field screened at the N-E-S-W sides of the wellhead. Soil samples were taken along the flowline at any points of material change and/or hammer unions, directional changes, as well as at the bell holes on either side of a waterway.

PROPOSED SAMPLING PLAN

Proposed Soil Sampling

Will soil samples be collected as part of this investigation? (Number, type (grab/composite), analyses, and locations of samples):

A grab soil sample will be collected at the base of the excavation or the area showing the highest degree of impact during field screening activities at the wellhead excavation. Additionally, soil samples will be field screened at the N-E-S-W sides of the wellhead. Soil samples were taken along the flowline at any points of material change and/or hammer unions, directional changes, as well as at the bell holes on either side of a waterway. Soil samples were / will be analyzed by a certified laboratory for the full extent of Table 915-1, including but not limited to: TPH (total volatile [C6-C10] and extractable [C10-C36] hydrocarbons) organic compounds in soil per ECMC Table 915-1, and EC, SAR, pH, metals, and boron. All samples collected were/ will be analyzed by a certified laboratory using approved ECMC laboratory analysis methods.

Visual inspection of the wellhead and flowline areas occurred / will occur during abandonment activities. Field personnel field screened/ will field screen all disturbed areas using visual and olfactory senses to determine if laboratory confirmation sampling was / is required. The ECMC Flowline Closure and Wellhead Closure Checklists were / will be utilized and filled out during the abandonment process. A photolog will be submitted on the Subsequent Form 27.

Two background soil samples were collected from one discrete location near the flowline (BKG01) and analyzed for pH, EC, SAR, boron and metals in soil per ECMC Table 915-1. Background soil samples were collected from the depths of one feet and two feet below ground surface (ft bgs). Arsenic and selenium were observed to be above ECMC Table 915-1 standards in native soil. Additional background samples will be collected concurrently with the supplemental site investigation.

Concurrently with the remedial excavation that is proposed in the Remedial Action Plan section of this Form 27, background soil samples will be collected to determine if pH, SAR, EC, arsenic, and cadmium are attributed to native soil conditions at the site. The implementation schedule has been changed due to the decommissioning of the Bruntz G16-23 Flowline and necessity for supplemental site investigation activities adjacent to the flowline. The proposed site investigation will be completed following the approval of this form, landowner negotiations, and crew availability.

OPERATOR COMMENT

This Form 27 is being submitted to include the decommissioning results and historic reportable release discovered at the former Bruntz G16-23 Wellhead and Flowline location. A proposal to excavate the organic exceedances observed at sample locations FL01-01, FL01-02, FL01-03, FL01-06 and FL01R-W is presented in the Site Investigation Report and Remedial Action Plan sections of this Form 27.

Based on the exceedances identified during decommissioning, Noble proposes to limit excavation confirmatory soil sampling to Organic Compounds in Soil per ECMC Table 915-1, pH, EC, SAR, arsenic, and cadmium. Concurrent with excavation activities, additional background samples will be collected to determine if pH, EC, SAR, arsenic and cadmium observed at this location are indicative of native material conditions.

Quarterly reporting will be conducted until closure criteria are achieved for the remediation project. The results of the supplemental site investigation will be submitted on a subsequent Form 27.
