 Nature of complaint: Complainant had concerns with excessive invasive weeds growing along the well location pad and access road as well as a dangerous bridge along the access road. The complaint was submitted 06/28/2024. ECMC staff will not be addressing the dangerous bridge as that would be considered a civil matter. During the inspection it was observed by ECMC staff that the access road had been mowed however Scotch thistle and Curly dock were observed still growing along the access road right of way. It was observed as well that Kochia and Curly dock have been left unmanaged across the well location, therefore the Operator shall control and manage all weeds and noxious weeds across the entirety of the location and access road.

Corrective Action: **Operator will comply with Rule 606 and 1003.f to manage all weeds along the access road and at the well location.**
