Comment:	<p>Complaint: #403846335 Field Inspector Assigned: Dylan Edwardson Location ID: #305848 Well API: #123-23565 Inspection Document: #708201403 Nature of complaint: Complainant has concerns that the Warner 4-18 has been abandoned and neglected with storage of oil and gas parts and noxious weeds within the fenced area. Complainant also stated that flowlines were removed 3 years ago and that the potholes have not been reclaimed, as such, the potholes are creating issues with their farming equipment. It was also stated that the two track access road is no longer visible and the complainant doesn't want a new two track access road in the hay filed because the old one can't be seen.</p> <p>At the time of this inspection, Staff observed that subsidence is occurring around the former potholes used for flowline removal and that both the well location and flowline potholes have evidence of undesirable vegetation (kochia) and non-uniform vegetation cover. The Warner 4-18 (API 123-23565) has been placed on a Form 6A Out of Service Designation list (doc #403108165) with a plugging due date of 12/31/2030. ECMC Staff contacted Operator representatives (D. Stromo and J. Brady) who indicated to Staff that the Warner 4-18 well will be placed on a plugging and abandonment list for a future date in Q3/Q4 of 2024. Undesirable vegetation will be addressed under "Good Housekeeping" section and the Operator shall coordinate with the affected surface owner to resolve subsidence observed along flowline potholes prior to P&amp;A activities.
