INITIAL ACTION SUMMARY

Description of initial action or emergency response measures take to abate, investigate, and/or remediate impacts associated with E&P Waste.

Pursuant to ECMC Rule 911 a site investigation was conducted pertaining to the HSR-EACHUS 3-23 wellhead cut and cap and flowline removal. The wellhead was cut and capped per ECMC rules. Approximately 274' of flowline was removed.

PROPOSED SAMPLING PLAN

Proposed Soil Sampling

Will soil samples be collected as part of this investigation? (Number, type (grab/composite), analyses, and locations of samples):

Eight (8) grab soil samples were collected at the wellhead excavation (5), flowline directional changes (2), and flowline terminus at the separator (1). Additionally, soil samples were field screened at the N-E-S-W sides of the wellhead. Soil samples were analyzed by a certified laboratory for the full extent of Table 915-1, including: TPH (total volatile [C6-C10] and extractable [C10-C36] hydrocarbons), organic compounds in soil per ECMC Table 915-1, EC, SAR, pH, metals, and boron. All samples collected were analyzed by a certified laboratory using approved ECMC laboratory analysis methods.

No current source was generated. Residual petroleum hydrocarbon impacts will be removed through excavation. Noble proposes an amended Table 915-1 analytical plan to include TPH (C6-C36), ECMC Table 915-1 organics, arsenic, barium, lead, and selenium. Additional backgrounds (5+) will be collected from soil of native/similar lithologic material not impacted by oil and gas activity to further compare applicable metals, as needed.

Describe how remediation of existing impacts to soil and groundwater is to be accomplished (i.e. summarize remedial action plan).
