INITIAL ACTION SUMMARY

Description of initial action or emergency response measures take to abate, investigate, and/or remediate impacts associated with E&P Waste.

Wellhead cut and cap operations were completed at the Hart-Memco 1-22 wellhead on May 2, 2024. Groundwater was not encountered in the wellhead cut and cap excavation. Visual inspection and field screening of soil around the wellhead and associated pumping equipment were conducted following cut and cap operations, and a soil sample (B01@7') was submitted for analysis of full list Table 915-1 constituents to determine if a release occurred. The flowline associated with the wellhead was removed between May 2 and June 12, 2024, and soil samples were collected from the locations where the flowline risers were disconnected from the wellhead (WH01-RISER@4') and from the separator (SEP01-RISER@4'). The samples were submitted for laboratory analysis of full list Table 915-1 constituents to determine if a release occurred. Initial analytical results indicated that a pH concentration exceeding the Table 915-1 allowable level and background level was present at the B01@7' location. A verification sample was collected to confirm the initial results and final analytical results were in compliance with Table 915-1 standard or within site-specific background levels. The wellhead excavation and flowline potholes are depicted on Figures 1 and 2, respectively. The PID readings and soil sample results are summarized in Tables 1 and 2, respectively. On May 2 and June 10, 2024, soil samples were collected from the base of the cut and cap excavation (B01@7'), and from the locations where the flowline risers were disconnected from the wellhead (WH01-RISER@4') and from the separator (SEP01-RISER@4'). The samples were submitted for laboratory analysis of full list Table 915-1 constituents using ECMC-approved methods. Initial analytical results indicated that a pH concentration exceeding the Table 915-1 allowable level and background level was present at the B01@7' location. A verification sample was collected to confirm the initial results and final analytical results were in compliance with Table 915-1 standard or within site-specific background levels. The laboratory reports are attached.

Additional Investigative Actions

On May 2 and June 12, 2024, visual inspection and field screening of soil were conducted at three sidewall locations within the cut and cap excavation area, four locations at the ground surface adjacent to the excavation, and two pothole locations during flowline removal. Based on the inspection and screening results, hydrocarbon-impacted soil was not observed at the screening locations, and no soil samples were submitted for laboratory analysis from these areas, in accordance with the ECMC Operator Guidance. A photographic log is attached.

On May 21, 2024, a soil gas survey was conducted at three soil vapor points installed adjacent to the former wellhead location following cut and cap operations. Two additional points were blocked and could not be screened. GEM 5000 field readings were all non-detect for methane at all soil vapor points. The soil vapor point locations are illustrated on Figure 1. The soil vapor field form is included as an attachment.

Twelve background soil samples (Native-BG01@3' through Native-BG06@3' and Native-BG01@6' through Native-BG06@6') were collected from native material adjacent to the wellhead cut and cap excavation. The background soil samples were submitted for laboratory analysis of pH, electrical conductivity (EC), sodium adsorption ratio (SAR), boron, and Table 915-1 metals using ECMC-approved methods. Laboratory analytical results indicated that levels of pH, arsenic, barium, cadmium, and selenium are naturally high in the soil. Analytical results from the background soil samples are presented in Table 2. The background soil samples are depicted on Figure 1.

Laboratory analytical results indicate that full list Table 915-1 constituent concentrations in soil samples collected from the base of the cut and cap excavation (B01@7') and during flowline removal activities (WH01-RISER@4' and SEP01-RISER@4') were in compliance with the ECMC Table 915-1 standards or within site-specific background levels; therefore, no soils were removed from the site during wellhead cut and cap or flowline removal operations. The excavation areas were backfilled and contoured to match pre-existing site conditions.

Laboratory analytical results indicate that full list Table 915-1 constituent concentrations in soil samples collected from the base of the cut and cap excavation (B01@7') and during flowline removal activities (WH01-RISER@4' and SEP01-RISER@4') were in compliance with the ECMC Table 915-1 standards or within site-specific background levels. Groundwater was not encountered in the cut and cap excavation or the flowline potholes. Based on the analytical and soil screening data presented herein, assessment is complete at this site and no further activities are required. As such, KMOG is requesting a No Further Action (NFA) determination for this location.
