Operator did not provide any explanation on how they determined the soil horizon thickness. ECMC staff, Chris Binschus, contacted the Operator on June 13, 2024 to explain this observation.

Operator has satisfied Item #3 from the previous corrective action, which identified that the 8" crude oil gathering line is installed at a depth of 5 feet below ground surface.
