A site investigation was conducted pursuant to COGCC Rule 911 at the BACON BOULTER BRANTNER T5N-R65W-S34 L01 Tank Battery location by Tasman Geoscience. WSP returned to the site for additional assessment on 3/31/22. Extent of impacts has not been fully delineated

A proposed SSI map is attached to this Form 27. Based on the contaminants of concern identified during decommissioning, Noble proposes to limit future soil sampling to Organic Compounds in Soil per ECMC Table 915-1, TPH, arsenic, selenium, and pH. Concurrently with the SSI, additional background samples will be collected to determine if arsenic, selenium, and pH should be considered contaminants of concern. The SSI will be completed in accordance with the proposed implementation schedule, and the results of the SSI will be submitted on a subsequent Form 27.
