Comment: There is erosion along the access road and no BMP's have been installed since previous inspection. There is no diversion for stormwater which is directed down the entire portion of the road causing further erosion. Sediment is being deposited offsite and there are insufficient BMP's installed to prevent erosion. Areas of erosion must be repaired and stabilized. BMP's must be implemented in accordance with good engineering practice and must be maintained. Previous corrective action has not been completed.
