COMMENTS:

This well started mitigation in October 2022. The bradenhead test conducted 06/20/2023 (Form 17 doc# 403440717) reported 250 psi. Following the previous period of blowdown mitigation, Extraction has not been able to effectively keep the bradenhead pressure below the action threshold. This can be seen in the pressure trends (charts attached) and the bradenhead test conducted 03/21/2024 (Form 17 doc # 403730226) reporting 267 psi, indicating a new mitigation plan is needed. In the interim, prior to P&A, Extraction plans to tie the Bradenhead into a near wellhead gas destruction device to consistently combust the gas and better ensure bradenhead pressure is stabilized below the notification threshold.

Prior to MIRU for P&A ops, Extraction has had to work through surface access constraints with the surface owner. To allow for these conversations and accommodate for burrowing owl stipulations, this well is planned to be plugged by 12/20/2024, per conversations with commission staff. Due to the surface access restraints, Extraction has been unable to move testing equipment to the wellhead to complete an updated form 17 to accompany this sundry submittal. However, a pre-P&A Bradenhead test will still be conducted within 60 days of P&A ops. For mitigation purposes, Extraction is working with the surface owner on an accelerated interim plan to move the near wellhead gas destruction device to the wellhead ASAP.

Extraction will provide an update after the well has been plugged.

Operator shall implement measures to control venting, to protect health and safety, and to ensure that vapors and odors from well operations do not constitute a nuisance or hazard to public welfare.2. Bradenhead gas is not to be vented to the atmosphere; any gas from the Bradenhead will be routed to the specified abatement system. Shut in bradenhead pressure shall not exceed 50 psig. Operator shall implement measures to get an estimate of the gas flow rate and/or volume from the bradenhead.3. Within thirty days of 7/19/2025, submit a Form 4 Sundry that summarizes current well condition. The sundry should include details of the future plans, sample analysis interpretation, bradenhead test description, and the flow rate information and pressure data.4. Shut well in for at least seven days to monitor build up pressures then conduct a new bradenhead test and submit the Form 17 within ten days of the test.5. If a sample has not been collected from surface casing within the last twelve months collect bradenhead gas samples for laboratory analysis. Sampling shall comply with Operator Guidance - Bradenhead Testing and Reporting Instructions, Appendix A: Liquid and Gas Sampling. Copies of all final laboratory analytical results shall be provided to the ECMC within three months of collecting the samples.
