A site investigation will be conducted pursuant to COGCC rule 911 at the State Bierstadt 4-65 35-34 2AH (467266) oil and gas location pertaining to the removal of (4) Separators, (2) 500-bbl Water Tanks, (4) 500-bbl Oil Tanks, (1) LACT, (1) Instrument Air Skid, (2) Combustors, (1) Bulk Separator, (1) Sales Gas Meter Bldg., (1) Sales Gas Scrubber. All other wells and equipment will remain active. See site map exhibit for details.

PROPOSED SAMPLING PLAN

Proposed Soil Sampling

Will soil samples be collected as part of this investigation? (Number, type (grab/composite), analyses, and locations of samples):

Grab confirmation soil samples will be collected from beneath the above ground oil tanks, water tanks, separators, LACT, and Sales Gas Scrubber. Soil samples will be analyzed by a certified laboratory for TPH (total volatile [C6-C10] and extractable [C10-C36] hydrocarbons), organic compounds in soil per COGCC Table 915-1, and EC, SAR, pH, metals, and boron. All samples collected will be analyzed by a certified laboratory using approved COGCC laboratory analysis methods.
