Dear Mr. Westbrook,

The plugged and abandoned CPC 4-42-4 well (*API #05-123-08861*) (the “*Well*”) is located on the lands referenced above which are owned by TL Summerfield LLC (“*Surface Owner*”). The Well was originally plugged and abandoned on June 24, 1996. Anadarko E&P Onshore LLC (“*Operator*”) has determined the Well needs to be accessed, re-entered and re-plugged to improve the integrity of its wellbore (the “*Operations*”). Prior to commencing the Operations, the Energy & Carbon Management Commission (“*ECMC*”) requires that the (1) Operator inform the Surface Owner of the Operations and (2) Operator shall obtain Surface Owner’s consent for the Operations. Operator hereby requests your consent to perform the Operations in accordance with the applicable rules and regulations of the ECMC. Upon completion of the Operations, Operator will reclaim all areas disturbed on the lands as a result of the Operations.


