INITIAL ACTION SUMMARY

Description of initial action or emergency response measures taken to abate, investigate, and/or remediate impacts associated with E&P Waste.

This form has been prepared to provide prior notice of additional site investigation of the former UPRR 43 Pan AM S #2 Tank Battery. The initial site investigation was performed by a third party on behalf of the surface owner and a Form 19 was submitted. Visual inspection and field screening of soils will be conducted during soil boring activities. Based on these observations, soil and groundwater (if present) samples will be collected and submitted for laboratory analysis of benzene, toluene, ethylbenzene, total xylenes (BTEX), naphthalene, total petroleum hydrocarbons (TPH)-gasoline range organics (GRO), TPH-diesel range organics (DRO), and TPH-oil range organics (ORO) analytes, to confirm potential impacts identified by the third party investigation. The topographic Site Location Map showing the geographic setting of the site is provided as Figure 1.

PROPOSED SAMPLING PLAN

Proposed Soil Sampling

☒ Will soil samples be collected as part of this investigation? (Number, type (grab/composite), analyses, and locations of samples):

Four soil borings will be advanced at the former facility. The soil borings will be conducted at the location of the former produced water vessel (PWV), former aboveground storage tank (AST), and two locations at the former separator. Borings will be advanced to a minimum of 15 feet below ground surface (ft bgs). Samples will be collected at 8 ft bgs to duplicate third party investigation samples, and at highest field screenings. Samples will be submitted to an accredited laboratory and analyzed for benzene, toluene, ethylbenzene, total xylenes (BTEX), naphthalene, total petroleum hydrocarbons (TPH)-gasoline range organics (GRO), TPH-diesel range organics (DRO), and TPH-oil range organics (ORO) analytes to confirm potential impacts identified by the third party investigation. Former facility infrastructure and the proposed soil sample locations are provided on Figure 2.

Proposed Groundwater Sampling

If groundwater is encountered during soil boring activities, a minimum of one grab sample will be collected as soon as practical. Groundwater samples will be submitted to an accredited laboratory for analytes listed in ECMC Table 915-1 Organic Compounds in Groundwater (benzene, toluene, ethylbenzene, total xylenes (BTEX), and naphthalene) using standard methods appropriate for detecting the target analytes in ECMC Table 915-1. If groundwater is encountered, temporary monitoring wells will be installed to collect samples.
