On Wednesday, 07/24/2024, Inspector Kirby Burchett, was on location to witness an Alternative MIT Bradenhead test at Utah Gas Op Ltd dba Utah Gas Corp on the Getty-Amoco 29 #29 well, Location #397207, in Rio Blanco County, Colorado.

This location is within or in close proximity to Parks and Wildlife (CPW) District with High Priority, NSO, Density, and Other Consultation Habitat regulations.

Any Corrective Actions from previous Inspections are still applicable.

Well is an open hole Mancos completion. Surface (7", 17#) set at 160'. 6-1/4" OH to 2750'. No Bradenhead annulus to monitor.

While there during normal operations no additional compliance issues were observed.

No follow up inspection is required.
