Pursuant to ECMC Rule 911 a site investigation was conducted pertaining to the HERBST 01-22-04-64 wellhead cut and cap and flowline removal. Approximately 565' of flowline was removed. The wellhead was cut and capped per ECMC rules.

Three (3) grab soil samples were collected at the wellhead excavation (1), and flowline terminuses at the wellhead (1) and separator (1). Soil samples were analyzed by a certified laboratory for TPH (total volatile [C6-C10] and extractable [C10-C36] hydrocarbons), organic compounds in soil per ECMC Table 915-1, EC, SAR, pH, and boron. All samples collected were analyzed by a certified laboratory using approved ECMC laboratory analysis methods.

Given the compliant analytical results from the wellhead assessment and in the absence of organic and other inorganic impacts, the elevated pH value at the flowline terminus appears to be de minimis in magnitude and is not indicative of an E&P release. Based upon the depth and level of soil suitability impacts, the risk to vegetation is likely negligible. Based upon this and the use of inspections to monitor future growth, no additional assessment or remediation appears necessary.

With the other analytes meeting the 915-1 screening levels and not indicative of a release occurring or operations negatively impacted the surrounding area, the pH result minimally outside the range is anticipated to be naturally occurring. Groundwater was not encountered during site activities. Noble is proposing no further action for this site.

	ECMC removes the Final Closure Request. ECMC requires background sampling to determine whether the pH value slightly outside the acceptable range is naturally occurring. The operator must address the elevated pH adequately by collecting background samples. Background sampling locations should be sufficiently distant from the impacted area to reflect conditions unaffected by oil and gas activity. Samples should be obtained from similar depths and soil horizons or lithologic materials to accurately compare and confirm soil samples.
