<p>Inspection #680102879 observed that the Location does not meet final reclamation requirements- "Access Road has not been reclaimed; debris (liner &, plastic pieces), gravel remains on site. There are areas which have sparse or are bare of, vegetation where it appears water pools which could be from inadequate recontouring." Inspection required Operator to comply with 1004 Rules.</p> <p>It was observed in this inspection that the Location remains out of compliance with 1004 Rules: Vegetation is not progressing towards 1004 uniform, desirable perennial vegetative establishment and the access road has not been reclaimed (gravel/culvert remains, areas over a drainage have not been contoured).</p> <p>This CA has not been addressed and remains applicable.</p>
