This location is within or in close proximity to, a CPW Density/High Priority Habitat, Black Bear, NSO Habitat, or Wildlife Management area. During the inspection, the following compliance issues were observed:

Tanks and Berms:

- 1) Open ended load line with a CA date of 8/2/2024
- 2) Multiple holes in secondary containment liner with a CA date of 8/12/2024

- 3) Missing tank battery sign with a CA date of 8/23/2024
