INITIAL ACTION SUMMARY

Description of initial action or emergency response measures take to abate, investigate, and/or remediate impacts associated with E&P Waste.

Pursuant to ECMC Rule 911 a site investigation will be conducted pertaining to the KERBS K20-06 flowline removal. Approximately 718' of flowline was removed. Additionally, soil samples were collected at any points of material change and/or hammer unions, directional changes, as well as at the bell holes on either side of a waterway, AS APPLICABLE to abandonment type. The wellhead was previously cut and capped per ECMC rules.

PROPOSED SAMPLING PLAN

Proposed Soil Sampling

Will soil samples be collected as part of this investigation? (Number, type (grab/composite), analyses, and locations of samples):

A grab soil sample was collected at the base of the excavation or the area showing the highest degree of impact during field screening activities. Additionally, soil samples were collected at any points of material change and/or hammer unions, directional changes, as well as at the bell holes on either side of a waterway. Soil samples were analyzed by a certified laboratory for TPH (total volatile [C6-C10] and extractable [C10-C36] hydrocarbons) organic compounds in soil per ECMC Table 915-1, and EC, SAR, pH, and boron. All samples collected were analyzed by a certified laboratory using approved ECMC laboratory analysis methods.

Four background soil samples were collected from an area not impacted by oil and gas development and at similar depths and lithologies as confirmation soil samples collected at the location and analyzed for Table 915-1 metals and soil suitability for reclamation standards (pH, EC, SAR, and Boron). Background soil sample analytical results were reported with elevated levels of arsenic and barium.

The source will be excavated and confirmation soil samples will be collected and analyzed for the full Table 915 suite. If groundwater is encountered during the excavation of impacted soil, a groundwater sample will be collected for all Table 915 constituents in groundwater. Should no additional active remediation be required following source removal at the location, a no further action (NFA) determination will be requested within 90 days following laboratory confirmation of the removal of impacted soils with respect to the applicable Table 915-1 screening levels at the site. If groundwater impacts are observed, an NFA will be requested once four consecutive quarters of groundwater sampling have been completed and reported at the location with concentrations of Table 915 constituents below regulatory limits. As needed, soil and/or groundwater remediation plans will be developed and submitted to ECMC in a supplemental Form 27.

The Implementation Schedule has been updated with proposed dates for completion of the site investigation and remediation based on crew availability.

OPERATOR COMMENT

The purpose of this form is to update the ECMC with data collected during the decommissioning of the flowline associated with the KERBS K 20-6 wellhead. Analysis of flowline confirmation soil samples was reported with an elevated concentration of Benzo (a) Anthracene at the FL01-2Ft sample location. Flowline confirmation and background soil sample analysis were reported with elevated concentrations of arsenic. The concentrations of arsenic in the flowline confirmation soil samples were within the natural variability seen in the background soil samples. It is suggested that concentrations of arsenic naturally occur in the native soil and should not be considered a COC for the flowline confirmation soil samples. This form also provides a timeline update in the Implementation Schedule section. A complete Flowline Closure Report will be provided in a subsequent form 27.
