<p>On July 23, 2024, a reportable release was discovered following the release of more than 1 barrel of fluid outside of secondary containment during well servicing operations at the Paragon Farms 42-25 Wellhead location. Cleanup and site assessment activities are currently ongoing. On July 24, 2024, a waste characterization soil sample (REL-B01@3") was collected from the material within the release area that was most likely to be impacted, based on field observations and PID readings, and submitted for laboratory analysis of the full Table 915-1 analytical suite using standard ECMC-approved methods appropriate for detecting the target analytes. Preliminary analytical results indicate that the BTEX, TMBs, TPH, PAHs, and various metal concentrations in soil sample REL-B01@3" exceeded the ECMC Table 915-1 Protection of Groundwater Soil Screening Level Concentrations. Additional analytical results are pending laboratory analysis and final reporting. Excavation and assessment activities are ongoing and will be summarized in a forthcoming quarterly Form 27-Supplemental Site Investigation and Remediation Workplan under Remediation Project No. 35990 (approved Form 27 Document No. 403826988). A topographic Site Location Map showing the geographic setting of the release is provided as Figure 1. The soil sample locations are illustrated on Figure 2. Soil sample location and field screening data are provided in Table 1. Preliminary soil analytical results are summarized in Tables 2 through 4. The preliminary laboratory analytical report is provided as Attachment A. Field notes and photographic log are provided as Attachment B.
