INITIAL ACTION SUMMARY

Description of initial action or emergency response measures take to abate, investigate, and/or remediate impacts associated with E&P Waste.

Pursuant to ECMC Rule 911 a site investigation was conducted pertaining to the SENECA E15-72-1HN wellhead cut and cap and flowline abandonment. The wellhead was cut and capped per ECMC rules. Approximately 556' of flowline was abandoned-in-place and the ECMC was notified on Form 44 Doc. # 403549953.

PROPOSED SAMPLING PLAN

Proposed Soil Sampling

Will soil samples be collected as part of this investigation? (Number, type (grab/composite), analyses, and locations of samples):

Three (3) grab soil samples were collected at the wellhead excavation (1) and flowline terminuses at the wellhead and separator (2). Soil samples were analyzed by a certified laboratory for TPH (total volatile [C6-C10] and extractable [C10-C36] hydrocarbons), organic compounds in soil per ECMC Table 915-1, EC, SAR, pH, and boron. One (1) waste characterization soil sample was analyzed for ECMC Table 915-1 metals.

A soil sample will be collected at the flowline directional change. Soil samples were/will be analyzed by a certified laboratory for the full extent of Table 915-1 including but not limited to: TPH (total volatile [C6-C10] and extractable [C10-C36] hydrocarbons) organic compounds in soil per ECMC Table 915-1, EC, SAR, pH, metals, and boron.

All samples collected were/will be analyzed by a certified laboratory using approved ECMC laboratory analysis methods.

No current source was generated. Residual petroleum hydrocarbon impacts identified at the former wellhead will be removed through excavation. Soil samples will be collected to delineate/confirm the vertical and lateral extents of the impacts following source removal. Noble proposes soil samples be collected for analysis TPH (C6-C36), ECMC Table 915-1 organics, arsenic, barium, SAR, and pH. Additional backgrounds (5+) will be collected from soil of native/similar lithologic material not impacted by oil and gas activity to further compare applicable metals and inorganics, as needed.
