Pursuant to ECMC Rule 911 a site investigation was conducted pertaining to the HSR-TUDOR 11-31A wellhead cut and cap and flowline removal. The wellhead was cut and capped per ECMC rules. Approximately 737' of flowline was removed.

Three (3) grab soil samples were collected at the wellhead excavation (1), and flowline terminuses at the wellhead (1) and separator (1). Soil samples were analyzed by a certified laboratory for TPH (total volatile [C6-C10] and extractable [C10-C36] hydrocarbons), organic compounds in soil per ECMC Table 915-1, EC, SAR, pH, and boron. All samples collected were analyzed by a certified laboratory using approved ECMC laboratory analysis methods.

OPERATOR COMMENT

This Form 27 is being submitted for HSR-Tudor #11-31A. In the absence of any elevated hydrocarbons, and with consideration to all soil suitability parameters and metals concentrations in compliance with ECMC Table 915-1, the slightly reduced pH found at FL-01-B, 5.29, is not indicative of a release. Noble, however, is proposing a site assessment be scheduled to delineate residual pH at the flowline terminus at the separator. Reclamation will be in accordance with ECMC 1000 Series Rules. Residual pH will be confirmed as still present, and previous values will be laterally and vertically defined. If residual pH is observed and is delineated, a detailed reclamation plan will be provided in a Supp. 27 as applicable to close Remediation Number 27627 with ECMC.
Groundwater was not encountered during decommissioning or site assessment activities.
