Grab confirmation soil samples were collected from the produced water vessel(s) excavation, beneath the ground oil tank(s), and at the risers for the flowline(s) and dumphine(s) of any separator(s). Soil samples were analyzed by a certified laboratory for TPH (total volatile [C6-C10] and extractable [C10-C36] hydrocarbons), organic compounds in soil per ECMC Table 915-1, and EC, SAR, pH, and boron. All samples collected were analyzed by a certified laboratory using approved ECMC laboratory analysis methods.

Fifteen background soil samples were collected from an area not impacted by oil and gas development and at similar depths and lithologies as confirmation soil samples collected at the location and analyzed for Table 915 metals and soil suitability for reclamation standards (pH, EC, SAR, and Boron). Background soil sample analytical results were reported with elevated concentrations of arsenic, lead, and a low pH.

The purpose of this form is to update the ECMC with data collected during the decommissioning of the BARNARD-64N65W 4SWNW facility. When available, a full decommissioning report with a photolog and figure set will be provided. In the interim, available data has been provided. Analysis of facility confirmation soil samples was reported with no elevated concentrations of Table 915-1 organic compounds. Facility confirmation and background soil sample analysis were reported with concentrations of arsenic and lead in exceedance of Table 915-1 standards. The Site Investigation Report background section provides an analysis of the background soil sample data. Additional soil samples will be collected as suggested in the Site Investigation Report section. A timeline update has also been provided in the Implementation Schedule section.
