Summary: There are 8 water wells within approximately a one and one half mile radius of the G.A. Henderson #6. All are completed in sandstone lenses of the Pierre formation at depths ranging from 46 ft. to 700 ft.

The Sandstone members of the Pierre are not continuous. When they do occur they yield fair quality water in very unpredictable quantities.

Of the 8 wells:

4 are commercial, and are used as source wells for secondary recovery projects. 3 of the wells are completed in the 700 ft. interval, 1 is completed in the 430 ft. interval

3 are registered for use as domestic and domestic and stock purposes and completed in the 430 ft. interval

1 is registered for stock use and is completed at 46 ft.
