INITIAL ACTION SUMMARY

Description of initial action or emergency response measures take to abate, investigate, and/or remediate impacts associated with E&P Waste.

Pursuant to ECMC Rule 911 a site investigation will be conducted pertaining to the Gemini G Federal 06-33 wellhead cut and cap and flowline removal. Approximately 1169' of flowline was removed. The wellhead will be cut and capped per ECMC rules. Additionally, soil samples will be field screened at the N-E-S-W sides of the wellhead. Soil samples were taken along the flowline at any points of material change and/or hammer unions, directional changes, as well as at the bell holes on either side of a waterway. The Flowline Pre-Abandonment Notice Document number is included under Related Forms.

PROPOSED SAMPLING PLAN

Proposed Soil Sampling

Will soil samples be collected as part of this investigation? (Number, type (grab/composite), analyses, and locations of samples):

A grab soil sample will be collected at the base of the excavation or the area showing the highest degree of impact during field screening activities at the wellhead excavation. Additionally, soil samples will be field screened at the N-E-S-W sides of the wellhead. Soil samples were taken along the flowline at any points of material change and/or hammer unions, directional changes, as well as at the bell holes on either side of a waterway. Soil samples will be analyzed by a certified laboratory for the full extent of Table 915-1, including but not limited to: TPH (total volatile [C6-C10] and extractable [C10-C36] hydrocarbons) organic compounds in soil per ECMC Table 915-1, and EC, SAR, pH, metals, and boron. All samples collected will be analyzed by a certified laboratory using approved ECMC laboratory analysis methods.

Proposed Groundwater Sampling

If groundwater is encountered during the site investigation a grab groundwater will be collected and analyzed for all organic and inorganic compounds per ECMC Table 915-1; this sample analysis includes, but is not limited to BTEX, naphthalene, 1,2,4-trimethylbenzene (TMB), and 1,3,5-TMB by EPA Method 8260, chloride and sulfate anions by EPA Method 300.0, and total dissolved solids (TDS) by Method SM 2540C.

Visual inspection of the wellhead and flowline areas will occur during abandonment activities. Field personnel will field screen all disturbed areas using visual and olfactory senses to determine if laboratory confirmation sampling is required. The ECMC Flowline Closure and Wellhead Closure Checklists will be utilized and filled out during the abandonment process. A photolog will be submitted on the Subsequent Form 27.

On May 14, 2024, two (2) background soil samples (BKG01) were collected topographically upgradient of the wellhead, from representative material at depths of approximately 4 feet and 5 feet bgs and submitted for preliminary analysis of the ECMC Table 915-1 metals, pH, EC, & SAR. Background analytical results indicate pH & arsenic in exceedance of the ECMC Table 915-1 standards in native material.

Following the discovery of the historic releases along the flowline associated with the Gemini G 06-33 wellhead, source mass removal activities are not scheduled at this time. Source mass removal activities will be initiated following land owner negotiations.

On June 13, 2024, two (2) historic releases were discovered following receipt of analytical results from soil samples collected during decommissioning activities at the Gemini G 06-33 wellhead, along the flowline. On May 13 & 14, 2024, five (5) soil samples (FL01R-W, FL01-02, FL01-02, FL01-07, & FL01-08) were collected along the flowline at depths ranging from approximately 4 feet to 5 feet below ground surface (bgs). The above-mentioned soil samples were submitted for laboratory analysis of the full Table 915-1 analytical suite. Analytical results indicated that organic compounds were in exceedance of the applicable Table 915-1 standards in soil samples FL01-07 & FL01-08. Excavation and confirmation sampling will be scheduled pending landowner approval.

GPS coordinates and PID readings for the soil samples collected during decommissioning activities are summarized in Table 1. Soil analytical results are summarized in Tables 2-5. Site topography is illustrated in Figure 1. Field screening and laboratory sample locations are illustrated on Figure 2. The laboratory reports are included as Attachment A and the field notes and photo log are included in Attachment B.

OPERATOR COMMENT

Based on correspondence from the ECMC, this Supplemental Form 27 was prepared for the historic releases discovered along the flowline associated with the Gemini G Federal 06-33 wellhead and in conjunction with the Supplemental Form 19s submitted under Document Numbers 403824824 & 403824819.

Excavation activities are not scheduled at this time. Following landowner negotiations, supplemental source mass removal activities will be initiated via mechanic excavation. PDC will be submitting an analyte reduction request for the director approval based on the constituents identified in the samples collected from the source material in a forthcoming Supplemental Form 27. Additionally, final analytical results for confirmation soil sampling activities adjacent to the wellhead will be summarized.
