<p>Pursuant to Rule 1004.a, all access roads to plugged and abandoned wells and associated production facilities shall be closed, graded and contoured. Culverts and any other obstructions that were part of the access road(s) shall be removed. Well locations, access roads and associated facilities shall be reclaimed. As applicable, compaction alleviation, restoration, and revegetation of well sites, associated production facilities, and access roads shall be performed to the same standards as established for interim reclamation under Rule 1003. All such reclamation work shall be completed within twelve (12) months on non-crop land after plugging a well or final closure of associated production facilities.</p> <p>Though the former pad has achieved a uniform, desirable perennial vegetative establishment pursuant to Rule 1004.c, it was observed in this inspection that the O&amp;G access road leading to the Location has not been reclaimed in accordance with Rule 1004.a- Gravel/road base material has not been removed, and compaction alleviation, contouring and reclamation work has not been performed. Additionally, degradation due to stormwater runoff is evident.</p> <p>Historic aerial imagery shows the road did not pre-exist the Location. Records show well was P&amp;A 9/28/2013- reclamation of the access road was required by 9/28/2014.</p>	trujilloam	08/02/2024
