Work over rig on-site for casing repair. Failed BOP due to slick line debris in rams. Personnel arrived in morning and discovered release occurred overnight. Approximately 70 bbls of produced water released into cellar and an estimated 10 bbls overflowed onto pad surface. 60 bbls were recovered from the cellar and pad surface surrounding the well. No liquid left location and clean up operations are ongoing.
