**INITIAL ACTION SUMMARY**

A site investigation will be conducted pursuant to ECMC rule 911 at the Conner 62N66W 34SENW (319538) oil and gas location pertaining to the removal and replacement of the partially buried produced water vault. See site map exhibit for details.

A grab confirmation soil sample will be collected from beneath the produced water vault as well as from the sidewall that indicated the highest field screening levels. Soil samples will be analyzed by a certified laboratory for TPH (total volatile [C6-C10] and extractable [C10-C36] hydrocarbons, organic compounds in soil per ECMC Table 915-1, Table 915 metals, and EC, SAR, pH, and boron. All samples collected will be analyzed by a certified laboratory using approved ECMC laboratory analysis methods.
