A site investigation will be conducted pursuant to COGCC rule 911 at the SCHEIDT-STATE-61N67W 16CSE (319599) oil and gas location pertaining to the cut/cap of the SCHEIDT-STATE 3-16 J (05-123-11541), decommission of production facilities and decommission of all on-location flowlines. Grab confirmation soil samples will be collected from beneath the above ground oil tank, water vault, separator, and wellhead. A grab confirmation soil sample will be collected from beneath the produced water vault as well as from the side wall that indicated the highest field screening levels. Soil samples will be analyzed by a certified laboratory for TPH (total volatile [C6-C10] and extractable [C10-C36] hydrocarbons), organic compounds in soil per COGCC Table 915-1, and EC, SAR, pH, metals, and boron. All samples collected will be analyzed by a certified laboratory using approved COGCC laboratory analysis methods.
