ECMC Inspection Report Summary

On Tuesday, 08/06/2024, Inspector Kirby Burchett, conducted a follow up field inspection at Hilcorp Energy Corp. on the Hiawatha B-2 well, Location #313074, in Moffat County, Colorado.

This location is within or close proximity to a Parks & Wildlife (CPW) District with High Priority, NSO, Density, and Other Consultation Habitat regulations.

Any Corrective Actions from previous Inspections are still applicable.

Follow up inspection in response to compliance issues observed during Insp. #715500002 on 5/7/24 and 2 previous inspections dating back to 12/8/23. The following Corrective Actions have not been resolved and original due dates will remain.

1. Random debris.
2. Unused equipment storage.
3. Equipment open to wildlife.
4. Unlabeled chemical tanks.
5. Production tanks missing required information.
6. No sign at tank battery.

Refer to Inspection Photos for observed compliance issues.

While there during normal operations the following compliance issues were observed:

1. Weeds.
2. Leaking equipment and stained soil.
3. Clumps of oily waste sprayed West from tank battery.

A follow up on this site inspection will be conducted to ensure all compliance issues have been corrected to comply with ECMC rules.
