INITIAL ACTION SUMMARY

Pursuant to ECMC Rule 911 a site investigation was conducted pertaining to the SATER USX CC19-10 wellhead cut and cap and flowline removal. The wellhead was cut and capped per ECMC rules. Approximately 1101' of flowline was removed. Flowline closure data will be included on a Supplemental Form 27

One (1) grab soil sample was collected at the wellhead excavation. One (1) grab soil sample was collected at the flowline terminus at the separator during the facility decommissioning assessment and was reported under Rem. # 26899 (Form 27 Document Number 403498915). Soil samples were analyzed by a certified laboratory for TPH (total volatile [C6-C10] and extractable [C10-C36] hydrocarbons), organic compounds in soil per ECMC Table 915-1, EC, SAR, pH, and boron. All samples collected were analyzed by a certified laboratory using approved ECMC laboratory analysis methods. Flowline closure data will be discussed on a Supplemental Form 27.
