Comment

Inspection #696205752 observed areas on the west end of the Location that are no longer necessary for production, and require reclamation pursuant to 1003 requirements; wells within these areas have been plugged and abandoned. All remaining production equipment is located on the eastern half of the working pad surface. Inspection required Operator to comply with Rule 1003.b by 5/17/2024.

It was observed in this inspection that corrective actions to comply with Rule 1003.b have not been taken by Operator; areas on the west end of the Location no longer necessary for production have not been reclaimed.

This CA has not been addressed and remains applicable.

Corrective Action

Comply with Rule 1003.b and conduct interim reclamation on areas no longer in use. Establish vegetation with total perennial, non-invasive uniform plant cover of at least eighty (80) percent of pre-disturbance or reference area levels. Use a seed mixture requested by the surface owner, or a mixture prescribed by the local soil conservation district. Ensure erosion controls are implemented to stabilize the seeded soil, and continue to monitor and manage Location until Final Reclamation has passed.
