### INITIAL ACTION SUMMARY

Description of initial action or emergency response measures take to abate, investigate, and/or remediate impacts associated with E&P Waste.

Wellhead cut & cap, onsite flowline removal, and facility decommissioning operations were completed at the Schneider 1-3 onsite wellhead and production facility 3/9/23 - 5/4/23. Visual inspection and field screening of soils around the wellhead, associated flowline, and facility equipment was conducted following wellhead cut and cap operations and facility removal activities, and soil sample (WH-B01@6', FL-B01@4', SEP-B01@3", SEP-B02@3", SEP-B02@6", SWT-B01@3") were submitted for laboratory analysis to determine if a release occurred. Laboratory analytical results indicated that boron was elevated in soil at the former separator location (SEP-B02@3"). An additional confirmation sample was collected at the former separator location (SEP-B02@6") and submitted for laboratory analysis of boron. Soil sample SEP-B02@6" Boron was re-run twice, both re-run results confirming Table 915-1 compliance. Per discussion with Chris Sanchez, the site was revisited on 4/24/24 and all previous assessment soil sample locations were re-sampled and submitted to Origins Laboratory in Denver, Colorado for ECMC Table 915-1 PAH and Metals analysis to complete full Table 915-1 analysis. Additional background soil samples were also collected and submitted to Origins for Table 915-1 Metals analysis. On 7/30/24, excavation and confirmation sampling was completed at SEP-B02 sample location. Grab confirmation soil samples were collected from the 4 sidewalls and the floor of the excavation and submitted to Origins for Table 915-1 Boron analysis only per Chris Sanchez. All results are compliant, confirming elevated Boron was removed. See attached site investigation report for all figures, tables, photos, and laboratory analytical reports.

Form 6 document number 403237883 is related to this form.

Form 42 document number 403332727 has been related to this form. The onsite flowline was removed. The most recent pressure test results are attached.

Water well documents available on Colorado Division of Water Resources online database for water well receipt number 3674815 approximately 1,690' SW from the wellhead state a static groundwater level of 353' bgs. Per ECMC Rule 915.a., operators will adhere to the concentrations for soil cleanup in Table 915-1. Operators will use Residential Soil Screening Level Concentrations as cleanup levels.

ECMC previously interpreted 6" depth as feet instead of inches for separator samples.

All laboratory analytical results for TPH (C6-C36) and organic compounds of concern in soil are Tale 915-1 compliant, confirming there were no impacts to soil from oil and gas operations at the site. Metals concentrations in assessment soil samples are within Table 915- 1 Residential Soil Screening Level limits and/or background local cleanup level.
