INITIAL ACTION SUMMARY

Description of initial action or emergency response measures take to abate, investigate, and/or remediate impacts associated with E&P Waste.

Pursuant to ECMC Rule 911 a limited site investigation was conducted pertaining to the WELLS RANCH AA35-69-1HNB wellhead cut and cap and flowline removal. The wellhead was cut and capped per ECMC rules. An environmental assessment was unsuccessful at the time due to health and safety concerns/field constraints. Confirmation soil samples at the former wellhead will be collected via alternative methods. Approximately 1980' of flowline will be removed, however a portion of the flowline will be abandoned-in-place due to field constraints. The ECMC will be updated in a supplemental Form 27. So as to not disturb the area of field constraint, soil samples will be taken at the start and endpoint of the flowline where the area exists. Soil samples will also be taken along the flowline at any points of material change and/or hammer unions, directional changes, as well as at the bell holes on either side of a waterway.

PROPOSED SAMPLING PLAN

Proposed Soil Sampling

Will soil samples be collected as part of this investigation? (Number, type (grab/composite), analyses, and locations of samples):

A grab soil sample will be collected at the base of the excavation or the area showing the highest degree of impact during field screening activities at the wellhead excavation. A grab confirmation soil sample will be collected at the wellhead excavation and start/end points of the flowline. Additionally, soil samples will be field screened at the N-E-S-W sides of the wellhead. Soil samples will be analyzed by a certified laboratory for the full extent of Table 915-1, including but not limited to: TPH (total volatile [C6-C10] and extractable [C10-C36] hydrocarbons) organic compounds in soil per ECMC Table 915-1, and EC, SAR, pH, metals, and boron. All samples collected will be analyzed by a certified laboratory using approved ECMC laboratory analysis methods.

If groundwater is encountered during the site investigation a grab groundwater will be collected and analyzed for all organic and inorganic compounds per ECMC Table 915-1; this sample analysis includes, but is not limited to BTEX, naphthalene, 1,2,4-trimethylbenzene (TMB), and 1,3,5-TMB by EPA Method 8260, chloride and sulfate anions by EPA Method 300.0, and total dissolved solids (TDS) by Method SM 2540C.

Visual inspection of the wellhead area will occur during abandonment activities. Field personnel will field screen all disturbed areas using visual and olfactory senses to determine if laboratory confirmation sampling is required. The ECMC Wellhead Closure Checklist will be utilized and filled out during the abandonment process. A photolog will be submitted on the Subsequent Form 27.

Supplemental Form 27's will be prepared and submitted on a quarterly schedule to provide updates and progress of the remediation until closure criteria has been achieved.

OPERATOR COMMENT

This form is being submitted as a third quarter timeline update for the Well Ranch AA35-69-1HNB wellhead and flowline.

Decommissioning activities at the wellhead started on 6/26/2024. An environmental assessment was unsuccessful at the time due to health and safety concerns/field constraints. Confirmation soil samples at the former wellhead will be collected via alternative methods. Flowline decommissioning activities will be summarized in a subsequent supplemental form 27 submittal.

Pending location landowner approval and crew availability, Noble will complete the decommissioning of the site infrastructure as outlined in this proposed remediation workplan. Supplemental Form 27s will be prepared and submitted on a quarterly schedule to provide updates and progress of the remediation until closure criteria has been achieved.
