It was observed in this inspection that the location meets ECMC 1004.e.(2) reclamation requirements; vegetation has achieved total perennial uniform desirable plant cover of at least eighty (80) percent of pre-disturbance or reference area levels.

Concrete debris observed stored on the north end of the Location.

Both debris and the perimeter fence will require removal to receive final passing.
