INITIAL ACTION SUMMARY

Description of initial action or emergency response measures take to abate, investigate, and/or remediate impacts associated with E&P Waste.

Wellhead cut and cap operations were completed at the GNB W 31-3 wellhead on February 22, 2023. Groundwater was encountered in the cut and cap excavation at approximately 6 ft bgs. Visual inspection and field screening of soil around the wellhead and associated pumping equipment were conducted following cut and cap operations, and a soil sample (B01@6') was submitted for analysis of full list Table 915-1 constituents, to determine if a release occurred. The flowline associated with the wellhead was removed between February 22 and March 1, 2024. Soil samples were collected from the locations where the flowline risers were disconnected from the wellhead (WH01-RISER@3') and from the separator [SEP01-RISER@4'(31-3)] and from the locations where the flowline changed direction at sharp angles (FL01@4' and FL02@4'). Initial analytical results indicated that lead impacts exceeding the ECMC Table 915-1 allowable level and background level were present at the former wellhead riser location. A verification sample was collected to confirm the initial result and verified the lead impacts were present. As such, a Form 19 Initial/Supplemental Spill/Release Report (Document No. 403740000) was submitted on April 5, 2024, and the ECMC issued Spill/Release Point ID 486423. The wellhead excavation and flowline are depicted on Figures 1 and 2. The PID readings and soil sample results are summarized in Tables 1 and 2, respectively. The Form 44 is attached.

Assessment activities are ongoing and will be summarized in a subsequent Form 27 Supplemental report.

PROPOSED SAMPLING PLAN

Proposed Soil Sampling

Will soil samples be collected as part of this investigation? (Number, type (grab/composite), analyses, and locations of samples):

On April 15, 2024, additional sampling was completed at the former wellhead location and four confirmation soil samples were collected from the sidewalls of the excavation extent at approximately 3 ft bgs. The soil samples were submitted for laboratory analysis of the site-specific waste profile including boron, pH, and select Table 915-1 metals using ECMC-approved methods. An additional base sample was not required as the B01@6' sample collected on February 22, 2024 was within the ECMC Table 915-1 allowable levels or site-specific background levels for all analytes. Laboratory analytical results indicate that pH, barium, and lead impacts exceeding the ECMC Table 915-1 allowable levels and background levels are present along the northern and eastern sidewalls. Assessment activities are ongoing. The laboratory report is attached.

Proposed Groundwater Sampling

Will groundwater samples be collected as part of this investigation? (Number, analyses, and locations of samples):

On February 22, 2024, one groundwater sample (GW01) was collected from the wellhead excavation and was submitted for analysis of Table 915-1 organic compounds. Based on the laboratory analytical results, groundwater concentrations were in full compliance with ECMC Table 915-1 allowable levels for organic compounds. An additional sample is still needed for inorganics assessment. The excavation groundwater sample location is depicted on Figure 1. The groundwater sample analytical results are summarized in Table 3.

Additional Investigative Actions

Additional alternative investigative actions described in attached Site Investigation Plan (summary):

On February 22 and February 27, 2024, visual inspection and field screening of soil were conducted at four sidewall locations within the cut and cap excavation area, four locations at the ground surface adjacent to the excavation, and five flowline potholes. Based on the inspection and screening results, hydrocarbon-impacted soil was not observed at the screening locations, and no soil samples were submitted for laboratory analysis from these areas, in accordance with the ECMC Operator Guidance. A photographic log is attached.

On February 27, 2024, a soil gas survey was conducted at four soil vapor points installed adjacent to the former wellhead location following cut and cap activities. A fifth point was blocked and could not be screened. GEM 5000 field readings were all non-detect for methane at all soil vapor points. The soil vapor point locations are illustrated on Figure 1. The soil vapor field form is included as an attachment.

Twelve background soil samples (Native-BG01 @3' through Native-BG06 @3' and Native-BG01 @6' through Native-BG06 @6') were collected from native material adjacent to the wellhead cut and cap excavation. The background soil samples were submitted for laboratory analysis of pH, specific conductivity (EC), sodium adsorption ration (SAR), boron, and Table 915-1 metals using ECMC-approved methods. Laboratory analytical results indicate that levels of pH, arsenic, barium, cadmium, lead, and selenium are naturally high in the native soil. The background soil sample laboratory analytical results are summarized in Table 2. The background soil sample locations are depicted on Figure 1.

Impacted soil from the wellhead cut and cap excavation will be removed and transported to a licensed disposal facility. Final disposal information will be provided upon completion of excavation activities. Disposal records will be kept on file and available upon request. The wellhead cut and cap excavation area will be backfilled and contoured to match pre-existing conditions.

Laboratory data indicate that pH, barium, and lead impacts exceeding the ECMC Table 915-1 allowable levels and background levels are present in the location of the former wellhead. Assessment activities are ongoing. Groundwater was encountered in the wellhead excavation at approximately 6 ft bgs. One groundwater sample was collected from the excavation and submitted for laboratory analysis. Analytical results indicate that groundwater concentrations are in full compliance with ECMC Table 915-1 allowable levels. Assessment activities are ongoing and will be summarized in a subsequent Form 27 Supplemental report.
