To date 500 cubic yards have been removed and hauled for disposal. Additional source removal will occur and soils will be field screened and confirmation soil samples will be collected and submitted for TPH (C6-C36) and Organics as previously approved on Form 19 Doc #403777903.

The Civitas Resources insurance program includes Excess Liability coverage of \$110,000,000 per occurrence and in the aggregate which sits over the sudden and accidental pollution within the General Liability coverage. It is the opinion of Civitas Resources that this total tower of limit is adequate to address the costs of remediation associated with any qualifying pollution event.
