INITIAL ACTION SUMMARY

Pursuant to ECMC Rule 911 a site investigation was conducted pertaining to the MEYER USX CC07-17 wellhead cut and cap and flowline removal. The wellhead was cut and capped per ECMC rules. Approximately 210' of flowline was removed.

Two (2) grab soil samples were collected at the wellhead excavation (1) and flowline terminus at the wellhead (1). Additionally, soil samples were field screened at the N-E-S-W sides of the wellhead. One (1) soil sample was collected at the flowline terminus at the separator during the facility decommissioning assessment and was reported under Rem. # 31834 (Form 27 Document Number 403679058). Soil samples were analyzed by a certified laboratory for the full extent of Table 915-1, including: TPH (total volatile [C6-C10] and extractable [C10-C36] hydrocarbons), organic compounds in soil per ECMC Table 915-1, EC, SAR, pH, metals, and boron. All samples collected were analyzed by a certified laboratory using approved ECMC laboratory analysis methods.
