	<p>Previous inspection documented Operator performed additional final reclamation activities after receiving an approved seed mix from the Forest Service on October 6, 2023.</p> <p>After the 2024 growing season, there is virtually no desirable vegetation or even weed growth. Mulch is evident and providing temporary soil stabilization. Note- fencing remains and the western gate entrance was open at the time of this inspection and cattle presence is evident. Refer to the attached inspection photos.</p>	
Corrective Action:	<p>Comply with Rule 1004. Reseed disturbance areas using the approved seed mix provided by the Forest Service. Establish vegetation with total perennial, non-invasive uniform plant cover of at least eighty (80) percent of reference area levels. Ensure erosion controls are implemented to stabilize the seeded soil. Operator shall continue to monitor and manage this site until the location meets Rule 1004 standards, including stormwater and weed management.</p> <p>Operator shall perform soil testing to investigate soil properties related to soil suitability defined in Table 915-1.
