Pursuant to COGCC Rule 911 a site investigation will be conducted pertaining to the HOWARD A27-07 wellhead cut and cap and flowline removal. Approximately 2000' of flowline will be removed. The COGCC will be updated in a supplemental Form 27 if a portion of the flowline is abandoned-in-place due to field constraints. The wellhead will be cut and capped per COGCC rules. The Flowline Pre-Abandonment Notice Document number is included under Related Forms.

A grab soil sample will be collected at the base of the excavation or the area showing the highest degree of impact during field screening activities at the wellhead excavation. A grab confirmation soil sample will be collected at the wellhead excavation. Soil samples will be analyzed by a certified laboratory for TPH (total volatile [C6-C10] and extractable [C10-C36] hydrocarbons) organic compounds in soil per COGCC Table 915-1, and EC, SAR, pH, and boron. All samples collected will be analyzed by a certified laboratory using approved COGCC laboratory analysis methods.

During flowline removal, Operator observed soil impacts >915-1 adjacent to the wellhead and 30 feet south of the separator. Operator conducted a site investigation to determine the magnitude and extent of impacts at these two locations. Flowline impacts were observed at the sep. (1-MN) and wellhead (naptha). Site Investigation 6/14/22. No GW encountered so excavate (20'x20'x5') at WH and separator. Refusal at Separator at 12'. Refusal at WH at 35', no GW. See attached for details.

The source will be excavated and confirmation soil samples will be collected and analyzed for the full Table 915 suite. If groundwater is encountered during the excavation of impacted soil, a groundwater sample will be collected for Table 915 organic constituents in groundwater (BTEX, 1,2,4 Trimethylbenzene, 1,3,5 Trimethylbenzene, and Naphthalene). Should no additional active remediation be required following source removal at the location, a no further action (NFA) determination will be requested within 90 days following laboratory confirmation of the removal of impacted soils with respect to the applicable Table 915-1 screening levels at the site. If groundwater impacts are observed, an NFA will be requested once four consecutive quarters of groundwater sampling have been completed and reported at the location with concentrations of Table 915 constituents below regulatory limits. As needed, soil and/or groundwater remediation plans will be developed and submitted to ECMC in a supplemental Form 27.
