Pursuant to COGCC Rule 911 a site investigation was conducted pertaining to the AURORA USX AB25-25 wellhead cut and cap. The wellhead was cut and capped per COGCC rules. The flowline was previously abandoned on 4/10/2018, and the COGCC was notified on Form 44 Document number 402263524.

All samples collected were analyzed by a certified laboratory using approved COGCC laboratory analysis methods.

One background soil sample was collected near the wellhead and analyzed for pH, SAR, EC, and boron in soil per ECMC Table 915-1. The background soil sample was collected from 6 feet below ground surface (ft bgs). SAR and EC were not observed in the background soil sample above ECMC Table 915-1 standards.

A supplemental site investigation (SSI) will be completed to vertically and horizontally delineate the SAR and EC exceedances observed at sample location FL01A@6' during decommissioning. A proposed SSI map is attached to this Form 27. Based on the contaminants of concern identified in waste characterization sample FL01A@6', Noble proposes to limit future soil sampling to SAR and EC. Concurrently with the SSI, additional background samples will be collected to determine if SAR and EC should be considered contaminants of concern. The SSI will be completed in accordance with the proposed implementation schedule, and the results of the SSI will be submitted on a subsequent Form 27.
