INITIAL ACTION SUMMARY

Description of initial action or emergency response measures take to abate, investigate, and/or remediate impacts associated with E&P Waste.

Pursuant to COGCC Rule 911 a site investigation will be conducted pertaining to the MARKUS 01 wellhead cut and cap and flowline removal. Approximately 253' of flowline will be removed, however a portion of the flowline will be abandoned-in-place due to field constraints. The COGCC will be updated in a supplemental Form 27. The wellhead will be cut and capped per COGCC rules. Additionally, soil samples will be field screened at the N-E-S-W sides of the wellhead. So as to not disturb the area of field constraint, soil samples will be taken at the start and endpoint of the flowline where the area exists. Soil samples will also be taken along the flowline any points of material change and/or hammer unions, directional changes, as well as at the bell holes on either side of a waterway. The Flowline Pre-Abandonment Notice Document number is included under Related Forms.

PROPOSED SAMPLING PLAN

Proposed Soil Sampling

Will soil samples be collected as part of this investigation? (Number, type (grab/composite), analyses, and locations of samples):

A grab soil sample will be collected at the base of the excavation or the area showing the highest degree of impact during field screening activities at the wellhead excavation. Additionally, soil samples will be field screened at the N-E-S-W sides of the wellhead. Soil samples will be taken along the flowline at any points of material change and/or hammer unions, directional changes, as well as at the bell holes on either side of a waterway. Soil samples will be analyzed by a certified laboratory for TPH (total volatile [C6-C10] and extractable [C10-C36] hydrocarbons) organic compounds in soil per COGCC Table 915-1, and EC, SAR, pH, and boron. All samples collected will be analyzed by a certified laboratory using approved COGCC laboratory analysis methods.

If groundwater is encountered during the site investigation a grab groundwater will be collected and analyzed for all organic compounds and inorganic parameters (TDS, sulfate, chloride) per COGCC Table 915-1.

Visual inspection of the wellhead and flowline areas will occur during abandonment activities. Field personnel will field screen all disturbed areas using visual and olfactory senses to determine if laboratory confirmation sampling is required. The COGCC Flowline Closure and Wellhead Closure Checklists will be utilized and filled out during the abandonment process. A photolog will be submitted on the Subsequent Form 27.

Site investigation dates have been updated based on the dates most recent field activities were completed.

OPERATOR COMMENT

This form is being submitted as a third quarter timeline update for the Markus 01 Wellhead.

Facility decommissioning activities for the Markus 01 wellhead began on April 30, 2024. However, confirmation soil samples were unable to be collected at that time due to unsafe field conditions resulting from the high-water table and sidewalls caving into the excavation. Pending landowner approval and crew availability, plans to conduct confirmation soil sampling via hand auger as outlined in the approved initial Form 27 (document number 403442185) are expected to commence by the beginning of 4Q2024. The results of this environmental assessment will be summarized in a subsequent supplemental Form 27 submittal. Flowline decommissioning activities have commenced and will also be summarized in a subsequent supplemental Form 27 submittal as available.

Groundwater was encountered at approximately 2 ft-bgs during excavation of the wellhead during initial cut and cap activities. One grab groundwater sample (GW01) was collected and submitted to Origins for analysis of BTEX, naphthalene, 1,2,4-trimethylbenzene, and 1,3,5-trimethylbenzene by EPA Method 8260D, chloride and sulfate anions by IC 300.0 Method and total dissolved solids (TDS) by EPA Method 2540C. All analytical results for the groundwater sample submitted for analysis are compliant with their respective Table 915-1 Screening Levels except for TDS (860 mg/L). All organics were reported as below the laboratory method detection limits.

Sample location information is provided in Table 1 and Figure 1. Groundwater analytical results are summarized in Table 2 and Table 3. The laboratory analytical reports are also attached.
