INITIAL ACTION SUMMARY

Description of initial action or emergency response measures take to abate, investigate, and/or remediate impacts associated with E&P Waste.

In accordance with ECOM Rule 911, this form serves as notification for the removal of the flowline associated with the Dyer 42-7 wellhead. Please note that the wellhead and flowline were previously abandoned in 2004 prior to the flowline registration rules. The ground and sub-surfaces will be visually inspected for hydrocarbon impacts during abandonment activities. Field observations and photo documentation will be recorded in a field inspection form for submittal to the ECOM.

PROPOSED SAMPLING PLAN

Proposed Soil Sampling

Assessments will be conducted during the removal of the off-location flowline (estimated to be 945 feet in length) approximately every 250 feet. Laboratory soil samples will be collected below each endcap of the abandoned in-place flowline, at the halfway point, and at the change in direction (S-E). The flowline and adjacent sub-surface will be inspected for any visual and olfactory indicators of potential failure and hydrocarbon impacts. Soils will be field screened below the flowline and if suspected impacts are observed, a soil sample will be collected for an initial assessment and submitted for laboratory analysis of the full Table 915-1 analytical suite by ECOM approved methods. See the attached Figure 1 for an illustration of the flowline alignment and proposed soil sample locations.

If groundwater is encountered during decommissioning and/or abandonment activities, a grab sample will be collected as soon as practical. If contaminated soil is in contact with groundwater or if free product/hydrocarbon sheen are observed, the release will be reported in accordance with Rule 912.b. Groundwater samples will be submitted for laboratory analysis of BTEX, naphthalene, 1,2,4-trimethylbenzene, and 1,3,5-trimethylbenzene by EPA Method 8260, chloride and sulfate anions by EPA Method 300.0, and total dissolved solids (TDS) by Method SM 2540C.
