INITIAL ACTION SUMMARY

Description of initial action or emergency response measures take to abate, investigate, and/or remediate impacts associated with E&P Waste.

Excavation at SP4 and additional sampling was conducted on March 29, 2024, April 4, 2024, and May 29, 2024; soil samples were analyzed for Soil Solubility, Arsenic, Chromium (VI) and/or TPH impacts at 11 of the 12 sampling locations (SP1, SP2, SP3, SP4, SP6, SP8, SP14). Analytical Results for Excavation Soil Samples (EXSS01, EXSS02, EXSS03, EXSS04, EXSS05) were below TPH Table 915-1 Levels. 9 sample locations exceed Table 915-1 Levels for EC, pH, SAR, and Boron (EXSS01, EXSS02, EXSS03, EXSS04, EXSS05, SP2, SP3, SP4, SP8, SP14). Additionally, SP3 soil sample exceeds Arsenic Local Clean-Up Levels; Local Clean-Up Level is 11.91 mg/kg (1.25xBG(9.53mg/kg)). SP1 and SP6 are within the Background EC, pH, SAR, Boron and Arsenic Local Clean-up levels; Background analytical results exceed Table 915-1 Levels EC, pH, SAR, Boron and Arsenic.

Further delineation will be completed; Operator requests samples be analyzed for EC, pH, SAR and Boron. SP3 will be analyzed for EC, pH, SAR, Boron and Arsenic.
