Grab soil samples will be collected from areas most likely to exhibit E&P Waste impacts. Soil samples will be submitted for analysis of Table 915-1 parameters including organic compounds (TPH ranges C6-C36; BTEX; 1,2,4-Trimethylbenzene, 1,3,5-Trimethylbenzene, Naphthalene, PAH) and inorganic compounds (metals, soil suitability for reclamation).

The NATURAL RESOURCES GROUP INC. - 10369 SHANNON-ROBERTS #1-A (OWP) well (API #05-014-08698) and associated SHANNON-ROBERTS 61N68W 26NENE (OWP) Tank Battery (Location ID #321499) are in the Colorado ECMC Orphaned Well Program (OWP). Civitas Resources/Extraction Oil & Gas Inc. plugged and abandoned (PA) the SHANNON-ROBERTS #1-A (OWP) as part of a public project. This supplemental Form 27 presents soil analytical results for the wellhead cut and cap soil samples collected from the wellhead excavation. The ECMC OWP oversaw decommissioning of the related tank battery and removal/abandonment of the flowlines. Site investigation and remediation will proceed under Remediation Project #27481.
