Locate well on section grid in proper location, and indicate extent of lease. Unless operations are commenced within 180 days after the date of approval hereof, this approval to drill will become null and void.

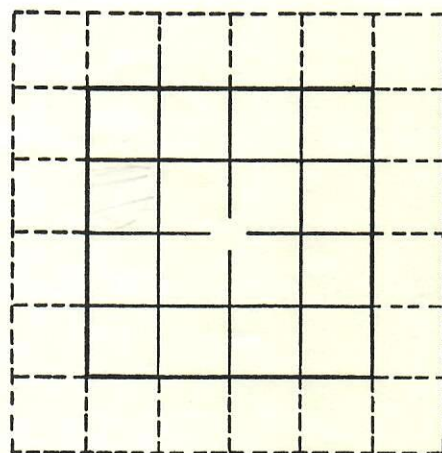

If commercial is encountered, will set full string of either 4 $\frac{1}{2}$  or 5 $\frac{1}{2}$  inch casing for production string, necessary 250 mesh slots will be run through production area.
