ASSIGNMENT OF OPERATING RIGHTS


KNOW ALL MEN BY THESE PRESENTS THAT:

TO HAVE AND TO HOLD the same subject to the terms and conditions contained in the above described Oil and Gas Lease and all applicable regulations appertaining thereto.


