This location is within or in close proximity to a CPW District with High Priority, NSO, Density, and Other Consultation Habitat Regulations.

Any Corrective Actions from previous Inspections are still applicable.

Follow up inspection in response to compliance issues observed during Insp> #715500528 on 8/6/24 and 2 previous inspections dating back to 2/21/24. The following Corrective Actions are unresolved and original due dates remain.

1. Random debris.
2. Unused equipment
3. No sign at tank battery
4. Production tanks missing required information
