INITIAL ACTION SUMMARY

Description of initial action or emergency response measures take to abate, investigate, and/or remediate impacts associated with E&P Waste.

Pursuant to ECMC Rule 911 a site investigation was conducted pertaining to the SHABLE 14-23 wellhead cut and cap. The wellhead was cut and capped per ECMC rules. Additionally, soil samples were field screened at the N-E-S-W sides of the wellhead. The flowline was previously abandoned on 11/21/2018, and the ECMC was notified on Form 44 Document number 403216829. A historical release was identified at the wellhead based on laboratory analytical results exceeding ECMC Table 915-1 protection of groundwater soil screening levels, only.

Five (5) grab soil samples were collected at the wellhead excavation, and soil samples were field screened at the N-E-S-W sides of the wellhead. Soil samples were analyzed by a certified laboratory for the full extent of Table 915-1, including but not limited to: TPH (total volatile [C6-C10] and extractable [C10-C36] hydrocarbons), organic compounds in soil per ECMC Table 915-1, EC, SAR, pH, metals, and boron. All samples collected were analyzed by a certified laboratory using approved ECMC laboratory analysis methods.

One (1) background sample was collected from similar lithologic material near the wellhead for EC, SAR, arsenic, barium, lead, and selenium analysis. Additional backgrounds (5+) were collected from an area off of the current pad, from material of comparable depth and lithology for further comparison of residual EC, SAR, arsenic, barium, lead, and selenium analysis.

Residual EC, SAR, arsenic, lead, and selenium values/concentrations are less than/consistent with local background comparison and do not appear to warrant additional assessment. Residual barium exceeds ECMC Table 915-1 Protection of Groundwater Soil Screening Levels (GSSLs) in soil at the site and in backgrounds. GSSLs do not appear applicable at the site, therefore, residual metals at the site do not appear to require additional assessment or remediation.

The source was delineated through a subsurface assessment, with samples collected for analysis of TPH (C6-36), ECMC Table 915-1 organics, EC, SAR, arsenic, barium, lead, and selenium in accordance with approved Form 27 Doc. # 403595539.

Results of the subsurface assessment indicate that residual petroleum hydrocarbon impacts have been vertically and laterally defined. Groundwater was not encountered during the subsurface assessment. The absence of groundwater and the local lithology suggests that a pathway to groundwater at this location is not likely. Therefore, Noble proposes to use ECMC Table 915-1 Residential Soil Screening Levels at the site.

All organic concentrations are in compliance with ECMC Table 915-1 Residential Soil Screening Levels. Residual EC, SAR, arsenic, lead, and selenium values/concentrations are less than/consistent with local background comparison and do not appear to warrant additional assessment. Residual barium exceeds ECMC Table 915-1 Protection of Groundwater Soil Screening Levels (GSSLs) in soil at the site and in backgrounds. GSSLs do not appear applicable at the site, therefore, residual metals at the site do not appear to require additional assessment or remediation.
