INITIAL ACTION SUMMARY

Description of initial action or emergency response measures take to abate, investigate, and/or remediate impacts associated with E&P Waste.

Pursuant to ECMC Rule 911 a site investigation was conducted pertaining to the PARKER 29-34 wellhead cut and cap and flowline removal. Approximately 3075' of flowline was removed. The wellhead was cut and capped per ECMC rules. Additionally, soil samples were collected at the point of wellhead excavation and at any points of material change and/or hammer unions, directional changes, as well as at the bell holes on either side of a waterway, AS APPLICABLE to abandonment type. The Flowline Pre-Abandonment Notice Document number was previously included under Related Forms.

A (1) grab confirmation soil sample was collected at the wellhead excavation. The sample was analyzed by a certified laboratory for TPH (total volatile [C6 -C10] and extractable [C10-C36] hydrocarbons), organic compounds in soil per ECMC Table 915-1, EC, SAR, pH, and boron. All samples were analyzed by a certified laboratory using approved ECMC laboratory analysis methods.
