INITIAL ACTION SUMMARY

Description of initial action or emergency response measures take to abate, investigate, and/or remediate impacts associated with E&P Waste.

Pursuant to ECMC Rule 911 a site investigation was conducted pertaining to the LONG C20-17 flowline removal. Approximately 1582' of flowline was removed. The wellhead was cut and capped per ECMC rules. Additionally, soil samples were field screened at the N-E-S-W sides of the wellhead. So as to not disturb the area of field constraint, soil samples were taken at the start and endpoint of the flowline where the area exists. Soil samples were also taken along the flowline any points of material change and/or hammer unions, directional changes, as well as at the bell holes on either side of a waterway. The Flowline Pre-Abandonment Notice Document number is included under Related Forms.

A grab soil sample was collected at the base of the excavation or the area showing the highest degree of impact during field screening activities at the wellhead excavation. Additionally, soil samples were field screened at the N-E-S-W sides of the wellhead. Soil samples were taken along the flowline at any points of material change and/or hammer unions, directional changes, as well as at the bell holes on either side of a waterway. Soil samples were analyzed by a certified laboratory for the full extent of Table 915-1, including but not limited to: TPH (total volatile [C6-C10] and extractable [C10-C36] hydrocarbons) organic compounds in soil per ECMC Table 915-1, and EC, SAR, pH, metals, and boron. All samples collected were and will be analyzed by a certified laboratory using approved ECMC laboratory analysis methods.

If groundwater is encountered during the site investigation a grab groundwater will be collected and analyzed for all organic compounds per ECMC Table 915-1 and inorganic parameters (TDS, chloride, sulfate, sodium, potassium, bicarbonate, and carbonate (as CaCO₃)).

Visual inspection of the wellhead and flowline areas occurred and will occur during abandonment activities. Field personnel field screened and will field screen all disturbed areas using visual and olfactory senses to determine if laboratory confirmation sampling was and is required. A detailed summary of decommissioning activities, including field notes, site photos, figures, and laboratory analytical results, is attached to this Form 27.

Four background soil samples were collected near the flowline and analyzed for metals in soil per ECMC Table 915-1, pH, SAR, EC, and boron. Background soil samples were collected from depths ranging between 0-0.5 and 5 feet below ground surface (ft bgs). The maximum background values for EC and SAR were observed to be 13.6 mmhos/cm and 12.2. The maximum background concentrations with a 1.25x multiplier applied for barium and lead were calculated to be 153 mg/kg and 73.9 mg/kg, respectively. All EC, SAR, barium, and lead values observed during decommissioning were below background levels. As such, EC, SAR, barium, and lead should not be considered contaminants of concern.

Based on the ECMC Table 915-1 exceedances identified during decommissioning, Noble proposes to limit future soil sampling to BTEX, naphthalene, 1,2,4-TMB, 1,3,5-TMB, TPH, PAHs, arsenic, and pH. If soil that is more heavily impacted with hydrocarbon compounds (based on PID readings, visual and/or olfactory indicators) is discovered during the remedial excavation, a soil sample will be collected from that location and analyzed for full ECMC Table 915-1 contaminants of concern. If additional analytes are discovered from this new waste characterization sample in exceedance of ECMC Table 915-1 standards beyond those proposed in the above amended sampling plan request, those compounds will be added to the sampling plan. The results of the remedial excavation will be submitted on a subsequent Form 27.

Basis for change in implementation schedule:

The implementation schedule has been changed due to the decommissioning of Long C20-17 flowline and necessity for remedial excavation activities adjacent to the flowline. The proposed remedial excavation will be completed following the approval of this form, landowner negotiations, and crew availability.

OPERATOR COMMENT

This Form 27 is being submitted to include the decommissioning and historic reportable release discovered at the former Long C20-17 flowline location. A proposal to excavate the organic compound exceedances identified during decommissioning (soil samples FL01-01@2.5' and FL01-06@3') is presented in the Remedial Action Plan section of this Form 27.

Three background soil samples (BKG01) were collected from adjacent to the flowline location and the lithology between the site and background locations were observed to be poorly graded sands. The maximum background values of EC and SAR were 13.6 mmhos/cm and 12.2, respectively. All site EC and SAR values were below this value. Furthermore the mean background values of EC was 7.54 mmhos/cm. The maximum background concentration of barium and lead were 122 mg/kg and 59.1 mg/kg, respectively. 1.25x the maximum background concentrations of barium and lead were calculated to be 153 mg/kg and 73.9 mg/kg, respectively. All site barium and lead concentrations were below this concentration. Furthermore, the mean background soil sample concentrations x1.25 for barium and lead were calculated to be 93.6 mg/kg and 29.0 mg/kg, respectively. Since the maximum and/or mean background concentrations/values for EC, SAR, barium, and lead were observed to be greater than then site concentrations/values, Noble requests EC, barium, and lead to not be considered contaminants of concern.

Based on the contaminants of concern identified during decommissioning, Noble proposes to limit future soil sampling to BTEX, naphthalene, 1,2,4,-TMB, 1,3,5-TMB, TPH (C6-C36), PAHs, arsenic and pH. Concurrent with remedial excavation activities, additional background samples will be collected to determine if arsenic pH, observed at this location is indicative of native material conditions.

Quarterly reporting will be conducted until closure criteria are achieved for the remediation project. The results of the background sampling and remedial excavation will be submitted on a subsequent Form 27.
